CASH GIFTS

Cash gifts are the most immediate and impactful way to support our Mission. You can give by check, credit card or electronic transfer, providing resources that will make an immediate difference with the people we serve.

GIFTS OF SECURITIES

Donating appreciated stocks, bonds or mutual funds can also provide significant tax advantages while supporting the Mission.

IRA CHARITABLE ROLLOVER

If you are 70½ or older, you can make a tax-free gift directly from your IRA each year. This is an easy way to meet your required minimum distribution and make a lasting difference.

DONOR-ADVISED FUND (DAF)

Simply recommend a grant from your DAF to support the Mount Carmel Foundation. It's a convenient way to give using funds you've already set aside for charitable purposes.

EMPLOYER MATCHING GIFTS

Multiply your impact! Many employers match charitable contributions. Check with your HR department to see if your gift qualifies.

PLANNED GIFT

Leave a lasting legacy by including Mount Carmel Foundation in your will, trust or as a beneficiary of retirement accounts or life insurance. You can also explore options like gifts of real estate, appreciated securities or life estate arrangements to maximize tax benefits.

You also may make a one-time gift or a pledge payable over multiple years, spreading your commitment across installments while still making a significant impact.

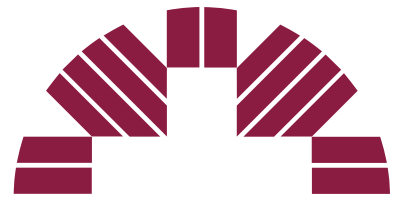
